His rate of pay will be \$20 per hours. There will be a probationary period of 3 months. Mark made the motion to hire David. Phil seconded it. The motion passed with 3 yes votes.

Mark stated that Lenox Propane will be here to set up the new tank.

Roadmaster:

It's springtime and we are patching pot holes. Wind and rain storms are keeping us busy picking and pushing trees out of the roads.
