Correspondence:

PENNDOT sent notification of a private heavy equipment action on-line.

Salt Springs Park Association asked for volunteers on April 23<sup>rd</sup>.

PA Municipal Trust sent the Total Account Value as of 3/31/22. It is \$154,372.91.

Pipeline Safety Bulletin sent notification of Important Safety Guidelines.

Coterra sent a proposed Diaz family LP Pad in Bridgewater Township.

Tract Engineering sent notification that Timothy Mark Smith is applying for a NPDES for Stormwater Associated with Mining Activities Notice of Intent for Coverage under the General Permit (GP-104) and General Permit for Bluestone Mining. Wartman 1 105 Quarry.

There is a problem on Booth Road in front for Docherty's.

Phil stated that there were some complaints about roads. FEMA work has a limitation on time, so the FEMA work will be the priority.

Lee made a motion to adjourn the meeting. Mark seconded the motion. The meeting was adjourned at 7:30 PM.
