Resolution # 2023-8 was also signed by the supervisors allowing United Fire Company to bill for and collect payment from any insurance company, including but not limited to motor vehicle insurance and homeowner's insurance for any services it renders, including those in response to said emergencies.

The supervisors agreed that a retainer of \$1000 be mailed to the township's attorney.

Phil made a motion to buy a piece of equipment for mow trimming, etc. for \$170,000. Mark seconded the motion. The motion passed with Mark and Phil voting yes and Lee voting no.

The supervisors the necessity of trimming and removing dead trees near the roads as a public safety issue, and to put the project out to bid. Mark made a motion. Lee seconded the motion. The motion passed with 3 yes votes.

There is a correction in the March 7th Minutes. Mirabito Fuel did not get the bid for propane. The Township will be getting propane from Lenox Propane.

Lee adjourned the meeting at 8:17 PM.
