September 5, 2023

The Franklin Township Regular Monthly Meeting was held on September 5, 2023 in the township building. Present at the meeting were Chairperson Lee Burch and Supervisors Phil DePue and Mark Creamer, Secretary/Treasurer Jeanne Sullivan and the people on the attached sign-in list.

Lee called the meeting to order at 7:02 PM. The pledge to the flag was recited.

Lee asked for a motion to accept the minutes. Mark made motion. Phil seconded the motion. The motion passed with 3 yes votes.

Lee asked for a motion to accept the treasurer's report. Mark made a motion. Phil seconded the motion. The motion passed with 3 yes votes.

Correspondence:

The 2022 Audit is complete. The advertisement will be put in the paper.

PMRS sent an e-mail for the 2024 Minimum Municipal Obligation worksheet. The employer contribution needs corrected. It states .05 but should be .13.

The Susquehanna County Township Official's Association sent a letter about the 110th Convention.

At the end of last month's meeting Lee handed Mark 4 Right-to -Know Law Request forms. They are listed as follows:

Mark explained that Lee had access to all the information as Supervisor and Chairman. There was no need for the requests. Lee has a key to the township building, access to all records including the minute book, resolution and ordinance book, bank statement, files, and older records. Jeanne told him in the past where records were located and if he couldn't locate what he was looking for she would assist him. He had been told in the past that a written request wasn't necessary. Lee stated he wanted something in writing, a written record of the requests. Therefore, the requests were noted in the meeting minutes.

Mark also brought up the \$1000 escrow holding tank check #7035 dated 9/17/2015 that is in uncashed in the file cabinet. Lee has referred to the check on several occasions wondering what should be done with it. Mark noted the fact that Lee was Supervisor and Chairperson at the time the check was submitted. Phil was not a Supervisor and Jeanne was not the Secretary/Treasurer at that time and have no knowledge of the check.
