

Monthly Meeting – June 4, 2024

The monthly township meeting was called to order by Supervisor Creamer at 7:05 pm, with Supervisor DePue present. The Pledge of Allegiance was recited.

Minutes from May 7, 2024 were read aloud by the Secretary/Treasurer then were approved with a motion by Supervisor Creamer and Supervisor DePue. The financial report was read aloud by the Secretary/Treasurer. A motion to approve the financial report was made by Supervisor Creamer and seconded by Supervisor DePue.

Supervisor DePue gave the Roadmaster Report as follows:

We screened millings from Snake Creek Marine and hauled them to township. We used chunks from screening millings to fill the parking yard of the township and topped it off. Wilber Stone gave us modified to stockpile. The modified is stockpiled on Tom Bolles land for the time being. We graded Potter Road and Booth Road. Our property in Franklin Forks was mowed.

The bids for Tar & Chip project were opened. The bids were as follows:

All of the bids for stone were approved by Supervisor Creamer and seconded by Supervisor DePue. However, the bids for Tar & Chip and FDR were tabled until the next meeting (July 2,

2024) to give the Supervisors time to review the projects due to the overall price being higher than anticipated.

Supervisor Creamer reviewed the following correspondences:

Notice of payment of \$676.86 from the State Police, Fines and Penalties will be paid in the month of June.

Following a request for discussion, Supervisor Creamer called on Joe Kempa to present plans for Richards to Kasperitis and Novakowski addition and changes to lands subdivision, along with plans for Arnold/White to Coy addition and changes to lands subdivisions within Franklin Township. Supervisor Creamer approved the plans and Supervisor DePue seconded the motion.

COMMENTS:

Dale Webster asked if the potholes on either side of the bridge on Franklin Forks will be filled in. Supervisor DePue stated he filled said potholes last week with millings, however, is unsure how to permanently fix the potholes.

Krista Naylor asked the Supervisors if there was a noise ordinance for Franklin Township, stating she is having an issue with her neighbor setting off fireworks randomly during the week, at sporadic times in the night to early morning. Supervisor Creamer informed her Franklin Township did have a noise ordinance, and he believed it began at 10pm. Supervisor Creamer informed Krista Naylor he would look through the Township's Ordinance book and email her the ordinance code.

Supervisor Creamer made a motion to adjourn the meeting at 8:30pm, seconded by Supervisor DePue.
