The monthly township meeting was called to order by Chairman Lee Burch at 7:00pm with Supervisor Mark Creamer present. Supervisor Phil DuPue arrived late. The Pledge of Allegiance was recited.

Minutes from August 6, 2024 was not reviewed by Chairman Burch, Supervisor Creamer and Supervisor Depue due to a mistake by the Secretary Janet Bolles. Janet Bolles will correct her mistake then August 6 minutes will be reviewed at the next meeting along with minutes from October 8, 2024.

The financial report was reviewed by Chairman Burch, Supervisor Creamer and Supervisor Depue. A motion to approve the financial report was made by Chairman Burch and seconded by Supervisor DePue and Supervisor Creamer.

Secretary/Treasurer Janet Bolles suggested Franklin Township stop using Waste Management for garbage disposal due to the increasing monthly price and switch over to Joe Disposal. Waste Management is costing \$275.46 a month for a 2 yard dumpster and Joe Disposal charges \$93 a month for the same 2 yard dumpster. Chairman Burch and Supervisor Creamer asked if there would be a fee for dumpster drop off from Joe Disposal and a fee for ending services with Waste Management. Secretary Bolles stated she would find out said information and get back to them.

Chairman Burch reviewed correspondence. Letter from Minute Men asking for donation. Chairman Burch motioned to match last year's donation. Supervisor Creamer and Supervisor DePue seconded.

Supervisor Depue gave the Roadmaster Report for September 3 cancelled meeting and for October 8 meeting:

September 3 –

Unplugged pipes and made sure water was back in the ditches after 3" to 4" of rain. Officially declared emergency and filed for damages the township sustained during rain storm. The process will take some time as it needs to go from County level to State level then finally to the Federal level before approval.

Tar & Chip was laid down on Booth Rd., Pratt Rd., School Rd., Bronson Hill and Melhuish Rd. Thursday and Friday the roads were swept and ready to do fog seal on them. On schedule to spray all 6.3 miles on September 4th.

Grader is becoming a big problem. The 4-wheel drive, injectors on the motor and several other things are having issues and parts seem to becoming obsolete. Possibly will need to purchase or rent another grader soon.
